



LIABILITY RELEASE AND HOLD HARMLESS AGREEMENT
(For Minor Child)

I, _____, legal guardian of _____ (“Child”), hereby agree to the following:

1. I give my Child permission to visit the premises of Full House All Stars, LLC located at 3 Bert Drive, West Bridgewater, Massachusetts (the “Facility”) and to travel with Full House All Stars, LLC teams to certain events at other locations (“Events”). I understand that while at the Facility and/or while attending Events, my Child may participate in activities including, but not limited to, cheerleading (which may include stunts such as pyramid-building), tumbling, gymnastics and other physical activities (“Activities”) and my Child may be in close proximity to other people participating in Activities. I recognize that certain Activities may require physical exertion, physical contact, and risk of falling, may be strenuous and may cause physical injury. I accept the risks involved with my Child participating in Activities and being around other people participating in Activities.
2. I understand that it is my responsibility to consult with a physician prior to and regarding my Child’s participation in Activities at the Facility and/or while attending Events. I certify that my Child is physically fit and does not have any medical condition that would prevent my Child’s full participation in the Activities at the Facility and/or while attending Events. In the event of an emergency, I give permission for Full House All Stars, LLC to give my Child first aid and to arrange for transportation to a hospital and emergency medical treatment.
3. In consideration for my Child being permitted to visit the Facility, attend Events, and/or participate in Activities at the Facility or while attending Events, to the fullest extent permitted by law, on behalf of myself and my Child, and our respective heirs, assigns and legal representatives, I knowingly, voluntarily and expressly release and waive any claims my Child or have or may have in the future against Full House All Stars, LLC, or any of its owners, members, managers, employees, coaches, instructors, and their respective successors or assigns, for any injuries or damages that my Child may sustain as a result of visiting the Facility, attending Events, traveling to or from Events, or participating in Activities at the Facility or while attending Events, regardless of whether any such injuries or damages are caused in whole or in part by negligence of one or more of the parties hereby released.
4. I further hereby agree to indemnify and hold harmless Full House All Stars, LLC, and its owners, members, managers, employees, coaches, instructors, and their respective successors or assigns, against any and all claims, damages, liabilities, costs and expenses, including reasonable attorneys’ fees, arising out of or relating to any injuries or damages that my Child may sustain as a result of visiting the Facility, attending Events, traveling to or from Events, or participating in Activities at the Facility or while attending Events, regardless of whether any such injuries or damages are caused in whole or in part by negligence of one or more of the parties hereby indemnified.
